Sir,

I am directed to inform you that upon consideration of various applications received by the Government through the Universities, the State Government accords its approval, under Section 43(4 and 5) of the Maharashtra University Act, 1974, for processing of applications by the University concerned, moved for opening of New Law Colleges from 1982-83 by the Managements at the places as indicated below:-

2. The above permission is granted subject to the following conditions:-

- (1) The aforesaid Law Colleges should be affiliated to the University concerned for the academic year 1982-83 in the first instance and the college should admit such number of students to LL.B. Course as may prescribed by the concerned University.
- (2) The Colleges should fulfill all the conditions as may be prescribed by the University while granting formal affiliation to the colleges.
- (3) The colleges will not be entitled to receive any maintenance grant from the State Government.

3. It is suggested that the Vice-Chancellor of your University may kindly consider, pending appointment of Local Enquiry Committees permitting, in exercise of the emergency powers, the colleges under reference to be opened from the current academic year presuming that the State Government would have no objection to issue orders of final approval under Section 43 (6 & 7) after the reports of the various statutory bodies of the University viz. Academic Council, Executive Council, and the Senate are received by the Government.

4. The proposals for final affiliation of the above Colleges by the University under Section 43(6 & 7) of the Act should be forwarded to Government along with reports of Local Enquiry Committee together with the reports of the concerned Statutory bodies in due course.
