**UNIVERSITY RULES AS TO ATTENDANCE, EXAM, WELFARE SCHEMES**

- Semester pattern of 70:30 marks
- 30 papers for three years' law course along with compulsory papers of AECC, DEGG, English
- 44 papers (14 Non-law and 30 law) papers for five years' law course along with compulsory papers of AECC, DEGG, English
- Duration of the course completion is N+2 rule where N stands for Normal duration of the course i.e. 3 years law must be completed within 3+2 =5 years and 5 years law course must be completed within 5+2=7 years from the date of admission otherwise the admission gets lapsed.
- Student can attempt the term-end university theory exam in Marathi language but the language of examination shall be selected while filling exam form for first semester.

- Various welfare schemes are available for the benefit of students. Students are advised to contact Student Development Department of the university. The necessary information is available on the website and the same can be received from the college office.
- LL.B. is a full time course hence, as per the BCI norms and university rules 70% classroom attendance is mandatory condition for filling the exam form, However, relaxation up to certain limit can be made available as per the prevalent rules.
- Students employed must secure NoC from the employer before the admission.
- Student has to comply with the necessary documents for the university eligibility failure to which the admission stands cancelled.
