All students of **Three Year Law Course and Five Year Law Course** to take note that instructions related to examination form filling are received as per circular received from Shivaji University. Therefore Students are instructed to fill the exam form of Shivaji University. Kindly observe the following schedule and fill the exam form in college.

Students are instructed to take note of the following

- 1) In continuation with previous notices issued by college and as per Rule 12 of Legal Education Rules 2008 and Ordinances 31 to 37 of Shivaji University, Kolhapur, all students, in order to be eligible for appearing in the internal and external examinations, are required to successfully complete the term to the satisfaction of the Principal and attend minimum 70 % of the number of lectures, tutorials & Practical Training engaged /conducted in each subject .
- 2) The student's attendance details are available with the respective Teacher Mentor. All students whose **attendance is above 70%** (without requirement of seeking relaxation) may fill the examination forms.
- 3) As per Ordinances 31 to 37, maximum 20 % relaxation on the ground of illness may be given on submission of certificate of medical practitioner. Therefore students (whose **attendance is more than 50 % but less than 70 %** and who wish to seek permissible relaxation are instructed to submit certificate of medical practitioner to Teacher Mentor before the last date of exam form.
- 4) Further, Students participation in competitions, sports for representing the college i.e. academic leave availed with prior permission of the Principal will be considered and added up to the attendance (applicable whose **attendance is more than 50 % but less than 70 %**). Therefore students who wish to avail permissible relaxation on this ground are instructed to submit such certificate to the Teacher Mentor before the last date of exam form.

- 5) Canvassing in any form/any attempt of canvassing for seeking relaxation otherwise than on permissible grounds will be treated as misconduct.
- 6) Further please note that if college fees are pending, kindly pay it.
